National Press Club event, 10 March (from the Australian Human Rights Commission):

How far have we come in our efforts to 'close the gap' in Indigenous life expectancy, and what's needed to close the gap by 2030?

Aboriginal and Torres Strait Islander Social Justice Commissioner, Mick Gooda, and National Coordinator Tackling Indigenous Smoking, Dr Tom Calma, are Co-chairs of the Close the Gap Campaign for Indigenous Health Equality. They will answer this question at the National Press Club on Thursday, 10 March 2011.

The Close the Gap Campaign has been an unprecedented 'movement' in the Indigenous health sphere and has played a direct role in bringing the Australian community together on the issue of making Indigenous health and improved life expectancy a national concern. It has also been extremely effective in bringing influence to bear on governments around the country to address Indigenous health equality with a unprecedented focus and unparalleled resource commitments. On 10 March, the campaign celebrates its fifth anniversary.

As previous Aboriginal and Torres Strait Islander Social Justice Commissioner, Dr Calma first called for a national effort to achieve health equality for Aboriginal and Torres Strait Islander people within 25 years. It was this call that spearheaded the campaign.

Dr Calma's address will highlight the five-years of progress towards achieving Indigenous health equality catalysed by the Close the Gap Campaign.

Commissioner Gooda will shine the light on what is needed to ensure the campaign remains on target to close the gap in life expectancy within a generation. This includes putting in place targets and adequate resources to address health inequalities, including providing equal access to primary health care for Indigenous Australians within 10 years.

'Ten indigenous graduates have gained admission to medical school in Darwin, a move being hailed as a big step towards closing the health gap between indigenous people and other Australians.

They were chosen after a process which replaced the usual 99.9 per cent academic pass rate requirement with a month-long assessment.

There are more than 150 indigenous doctors in Australia and while numbers have been increasing steadily, the intake of 10 in any medical school in one year is the biggest so far...'

Reform impacts on Aboriginal community controlled health, NACCHO/NRHA Joint Media Release, 17 February 2011

'The impacts of implementing recommendations made by the National Health and Hospitals Reform Commission—including Medicare Locals and Local Hospital Networks—are destined to play a crucial role in advancing the Aboriginal health reform agenda.

Next month in Perth the National Aboriginal Community Controlled Health Organisation (NACCHO) will present an Aboriginal Health Showcase to ensure health professionals and consumers are fully informed of the latest developments. The event is part of a pre-conference program ahead of the 11th biennial National Rural Health Conference to be held at the Perth Convention and Exhibition Centre from 13-16 March.

The NACCHO showcase, which will start at 11am on Sunday, 13 March, runs until 3pm. The objective is to provide health professionals with an Aboriginal community controlled perspective across the States and Territories, while also examining best practice governance models in health.

"Our 150 Aboriginal Community Controlled Health Services across the country are affected by the shortage of professional health staff," said NACCHO Chair, Justin Mohamed. "Our services are suffering, with the recruitment and retention of staff and providing adequate facilities being especially difficult. "NACCHO believes that Aboriginal people having more control over the design and delivery of Australia's health services will make lasting gains in helping to close the existing health gap between Aboriginal and non-Aboriginal peoples."

Gordon Gregory, Executive Director of the National Rural Health Alliance (NRHA) which is organising the Perth conference, joined NACCHO in calling for more health resources to be put into the areas of greatest need – including the health of Aboriginal people in metropolitan, rural and remote areas.

The NACCHO pre-Conference event will see Vicki O'Donnell and Sue Christopolos provide a Western Australian perspective on what it will mean to implement NHHRC recommendations. Others to provide regional views include NT representatives John Paterson and Chips MacKinolty, Andrew and Stephanie Bell from Central Australia, and Selwyn Button and Sheryl Lawton from the Queensland Aboriginal and Islander Health Council.

Medical Journal of Australia (MJA) is waiting for your contribution!

In view of disruptions by natural disasters in several Australian States, and in recognition that some stories are better told using images, not words, the editors of the MJA have decided to extend the deadline for this year's Dr Ross Ingram Memorial Essay competition, and have created a new category for the prize.

The MJA is looking for contributions that present original and positive ideas aimed at promoting health gains and health equity for Australia's Indigenous peoples. After all, real insights and solutions come from within, not from without. To enter, you need to be an Aboriginal or Torres Strait Islander person who is working or studying in a health-related field. The two categories are: essay (up to 2000 words long) and Original artwork – health related.

PhD top-up grant available to examine climate-morbidity and mortality relationships

Applications are invited from APA scholarship-ready students to participate in a funded 3-year NHMRC project that examines the health impacts of climate change on Indigenous Australians. This proposed research project is designed to quantify the health responses to temperature change by comparing Indigenous with non-Indigenous people. The project will focus on people living in Darwin, with the possible inclusion of an additional site.

This project needs a dedicated student researcher to explore the relationship between climate and health outcomes and conduct scenario-based modelling of likely future climate impacts. It is anticipated that the student will have a background in epidemiology, biostatistics or population health; is experienced in relevant quantitative methods, and has an interest, or previous experience, in climate impacts. The student will join either The School of Medicine (UWS) or the Climate Change Research Centre (UNSW) and will receive further training in climate related sciences as necessary. The successful candidate will be based in Sydney, but will travel interstate for limited periods to carry out project work. The candidate will be co-supervised by Associate Professor Hilary Bambrick (UWS) and Dr Lisa Alexander (UNSW). The total top-up scholarship available for the student is up to \$10,000/yr for three years in addition to the APA scholarship.
